

AFFIDAVIT of PROBABLE CAUSE

Your afflant, Detective Kim Lippincott, is employed by the Monroe County Office of the District Attorney. As a police officer in the Commonwealth of Pennsylvania I state the following:

On October 24, 2023 I located an advertisement on a website known to be used for the purposes of prostitution. The advertisement was for "Sweet like caramel baby" and was timestamped 09:17AM 2023-10-24. The advertisement included several photographs which were of a black female wearing red lingere posing in various positions. One of the photographs was of the woman's bare buttocks, and one was her posing on the ground with her mouth open.

At the bottom of the advertisements jut stated a list of 'activities this service provider may enjoy', those activities included deep throat, face sitting, intercourse, oral, and more.

The phone number associated with the advertisement was 570-230-8924. I began communicating with her, posing as an undercover sex buyer, at 9:31am. An agreement was made to meet at the Value Inn located at 5219 Milford Road in Middle Smithfield Township at noon to engage in sex for money. The payment she requested was \$160 for a half hour.

Closer to the meeting time she reached out to me to confirm our appointment and stated that she would have a friend with her to keep her company until I arrived. She instructed me to pull up to her and pay her, then she would go get the room, then she would need 5 minutes to get ready and I would be able to enter the room.

The female also instructed me to pick up condoms on my way, and prior to my arrival again asked if I had condoms, to which I replied that I had them. The female also sent me a selfie photograph of her standing outside the hotel wearing a green sweater.

Surveillance was set up by detectives in the hotel parking lot. We observed the female from the advertisement and selfie photograph along with another female. They both appeared to be looking around. An undercover male police officer then arrived in an undercover vehicle. He approached the female who then hugged him and asked him for the money. He pald her \$200. The undercover officer and the one female then began walking to the hotel office. At that time, both females were taken into custody.

I, <u>DETECTIVE KIM LIPPINCOTT</u>, BEING DULY SWORN ACCORDING TO THE LAW, DEPOSE AND SAY THAT THE FACTS SET FORTH IN THE FOREGOING AFFIDAVIT ARE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE, INFORMATION AND BELIEF.

AFFIDAVIT of PROBABLE CAUSE CONTINUATION

The female from the advertisement and selfie photograph was identified as SUNTOYA TUCKER. The other female was identified as BETTY MERWEDE.

Both females were in possession of their cell phones at the time of their arrest. MERWEDE had two bags with her.

Interviews were conducted post Miranda.

TUCKER stated that she met someone online who taught her how to place and advertisement and instructed her on what to do. TUCKER stated that MERWEDE, her wife, was with her to keep her safe in case anything bad happened. Additionally, TUCKER stated that she and MERWEDE came up with this plan so that they could make money to pay their rent because they will soon be evicted.

TUCKER provided consent to search for her cell phone and provided us with the passcode. TUKERs cell phone was placed on airplane mode and secured in evidence. TUCKER also provided consent to search the two bags that were in MERWEDEs possession at the time of her apprehension. TUCKER further advised me that there was, or may be, a crack pipe in one of the bags.

MERWEDE denied knowledge of TUCKER prostituting.

MERWEDE provided consent to search for the bags.

The bags were searched and two crack pipes with residue were located. They were secured in evidence.

Your affiant respectfully requests that the defendants BETTY MERWEDE and SONTOYA TUCKER answer to these charges.





AFFIDAVIT of PROBABLE CAUSE

Your affiant, Detective Kim Lippincott, is employed by the Monroe County Office of the District Attorney. As a police officer in the Commonwealth of Pennsylvania I state the following:

On October 24, 2023 I located an advertisement on a website known to be used for the purposes of prostitution. The advertisement was for "Sweet like caramel baby" and was timestamped 09:17AM 2023-10-24. The advertisement included several photographs which were of a black female wearing red lingere posing in various positions. One of the photographs was of the woman's bare buttocks, and one was her posing on the ground with her mouth open.

At the bottom of the advertisements but stated a list of 'activities this service provider may enjoy', those activities included deep throat, face sitting, intercourse, oral, and more-

The phone number associated with the advertisement was 570-230-8924. I began communicating with her, posing as an undercover sex buyer, at 9:31am. An agreement was made to meet at the Value Inn located at 5219 Milford Road In Middle Smithfield Township at noon to engage in sex for money. The payment she requested was \$160 for a half hour.

Closer to the meeting time she reached out to me to confirm our appointment and stated that she would have a friend with her to keep her company until I arrived. She instructed me to pull up to her and pay her, then she would go get the room, then she would need 5 minutes to get ready and I would be able to enter the room.

The female also instructed me to pick up condoms on my way, and prior to my arrival again asked if I had condoms, to which I replied that I had them. The female also sent me a selfie photograph of her standing outside the hotel wearing a green sweater.

Surveillance was set up by detectives in the hotel parking lot. We observed the female from the advertisement and selfie photograph along with another female. They both appeared to be looking around. An undercover male police officer then arrived in an undercover vehicle. He approached the female who then hugged him and asked him for the money. He paid her \$200. The undercover officer and the one female then began walking to the hotel office. At that time, both females were taken into custody.

The female from the advertisement and selfle photograph was identified as SUNTOYA TUCKER. The other female was identified as BETTY MERWEDE.

Both females were in possession of their cell phones at the time of their arrest. MERWEDE had two bags with her.

Interviews were conducted post Miranda.

TUCKER stated that she met someone online who taught her how to place and advertisement and instructed her on what to do. TUCKER stated that MERWEDE, her wife, was with her to keep her safe in case anything bad happened. Additionally, TUCKER stated that she and MERWEDE came up with this plan so that they could make money to pay their rent because they will soon be evicted.

TUCKER provided consent to search for her cell phone and provided us with the passcode. TUKERs cell phone was placed on airplane mode and secured in evidence. TUCKER also provided consent to search the two bags that were in MERWEDEs possession at the time of her apprehension. TUCKER further advised me that there was, or may be, a crack pipe in one of the bags.

MERWEDE denied knowledge of TUCKER prostituting.

MERWEDE provided consent to search for the bags.

The bags were searched and two crack pipes with residue were located. They were secured in evidence.
